#### **HISTORY**

Items donated by the family of John Vallee related to his time serving in the Civil War.

#### **Scope of Collection**

The bulk of the collection consists of military paperwork related to Capt. John Vallee's time serving in the Civil War, mostly as Captain in the 4th Battery. These include military orders to Vallee, a lot of Quartermaster records, allotment records, roll books and forms. Personal records of those who served under Vallee are also a big section, such as furlough permits, personal consent forms, records of money due from individuals, pension information, charges against officers, and personal letters.

There are a small number of Vallee's personal official papers, such as his citizenship application, military appointment, and discharge papers.

There are other items related more broadly to the Civil War, such as newspaper clippings, and a personal diary from George Gray, as well as more modern items such as transcribed letters, and a few brief typed biographies of other Beloit residents who served.
